The Government amended the Anti-Slavery Law to increase the penalties for slavery offenses and criminalize other slavery-like practices, including debt bondage. The Government also adopted the National Action Plan to Eliminate Child Labor, which aims to strengthen child labor laws and mobilize funds for social programs to withdraw children from child labor.~~
